ORDINANCE 2016-6

APPOINTED OFFICIALS AND EMPLOYEES OF THE CITY OF BOONVILLE FOR 2017

BE IT ORDAINED; BY THE COMMON COUNCIL OF THE CITY OF BOONVILLE, INDIANA:

Section One: From and after January 1, 2017, the following compensation shall be in effect for all appointed officials and employees of the City. Where compensation is listed as an hourly figure, such position is deemed an hourly position. Where such position shows a bi-weekly or monthly figure, such position shall be considered a salaried position.

Section Two: All payments for overtime compensation together with other fringe benefits shall be in addition to the annual compensation and shall not be considered as a part of the compensation set out in Section One.

Section Three: In addition to the compensation provided in Section One, all full time policemen and firemen shall be paid the sum of \$100 per holiday 14 days and all full time policemen and firemen shall be paid the sum \$1250.00 for uniform allowance in July and December of the calendar year 2017. Volunteer Firemen, after one year of employment, shall be paid \$400.00 for clothing allowance and \$12.50 per run for fire runs. To be paid semi-annually.

Section Four: All current full time employees of the City of Boonville covered under the personel policy of the City of Boonville with the exception of elected officials with one year of continuous service, shall be entitled to longevity pay. For the year 2017 all full time City employees shall be paid fifty dollars (\$50.00) gross for each calendar year of continuous employment after the first year of employment. Longevity pay shall be paid to said employees in January payroll of the month following the first year of employment.

Section Five: There shall be twenty-six (26) pay periods in the calendar year 2017.

Section Six: All ordinances in conflict with this ordinance are hereby repealed effective January 1, 2017.

ORDINANCE 2016 - 10

AN ORDINANCE ENACTING AND ADOPTING A SUPPLEMENT TO THE CODE OF ORDINANCES FOR THE CITY OF BOONVILLE, INDIANA

WHEREAS, American Legal Publishing Corporation of Cincinnati, Ohio, has completed the seventh (7) supplement to the Code of Ordinances of the Political Subdivision, which supplement contains all ordinances of a general and permanent nature enacted since the prior supplement to the Code of Ordinances of this Political Subdivision; and

WHEREAS, American Legal Publishing Corporation has recommended the revision or addition of certain sections of the Code of Ordinances which are based on or make reference to sections of the Indiana code; and

WHEREAS, it is the intent of the Legislative Authority to accept these updated sections in accordance with the changes of the law of the State of Indiana; and

WHEREAS, it is necessary to provide for the usual daily operation of the municipality and for the immediate preservation of the public peace, health, safety and general welfare of the municipality that this ordinance takes effect at an early date;

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE POLITICAL SUBDIVISON OF BOONVILLE, INDIANA:

- Section 1. That the seventh (7) supplement to the Code of Ordinances of the Political Subdivision as submitted by American Legal Publishing Corporation of Cincinnati, Ohio, and as attached hereto, be and the same is hereby adopted by reference as if setout in its entirety.
- Such supplement shall be deemed published as of the day of its adoption and approval by the Legislative Authority and the Clerk-Treasurer of the Political Subdivision is hereby authorized and ordered to insert such supplement into the copy of the Code of Ordinances kept on file in the Office of the Clerk-Treasurer.

ORDINANCE 2016 - 11

AN ORDINANCE OF THE CITY OF BOONVILLE, INDIANA, CONCERNING REMOVAL OF THE CITY OF BOONVILLE'S MUNICIPAL WATER UTILITY FROM THE JURISDICTION OF THE INDIANA UTILITY REGULATORY COMMISSION

WHEREAS, the City of Boonville, Indiana, (the "City"), has previously established a municipal water utility for purposes of operating water facilities and providing potable water service to customers in and around the City; and

WHEREAS, the rates, charges, evidences of indebtedness, and certain other matters concerning the City's municipal water utility are regulated by the Indiana Utility Regulatory Commission (the "IURC"); and

WHEREAS, the Common Council of the City (the "Council") recognizes that, pursuant to Indiana Code § 8-1.5-3-9 and 9.1, the majority of municipal water utilities in the State of Indiana have been removed from the IURC's jurisdiction as to rates, charges, evidence of indebtedness, and certain other matters; and

WHEREAS, the Council believes that: (i) the City is capable of appropriately establishing rates and charges, determining appropriate levels of indebtedness, and otherwise operating the City's municipal water utility without incurring the expense associated with the IURC's jurisdiction over such matters; and (ii) the City's municipal water utility should be removed from the IURC's jurisdiction; and

WHEREAS, the Council believes that it is important to obtain the input of the City's municipal water utility customers prior to completing the removal of the City's municipal water utility from the jurisdiction of the IURC; and

WHEREAS, at least thirty (30) days prior to the date of adoption of this ordinance, the City caused to be mailed to all ratepayers of the City's municipal water utility and to the IURC written notice of the meeting of the Council at which this ordinance was considered for adoption (the "Public Meeting"); and

WHEREAS, at the Public Meeting, the City provided an explanation of the removal process and all ratepayers of the City's municipal water utility and representatives of the IURC were provided with an opportunity to comment on the matter of the removal of the City's municipal water utility from the IURC's jurisdiction;

NOW, THEREFORE, be it ordained by the Common Council of the City of Boonville, Indiana that:

Section 1. Pursuant to Indiana Code § 8-1.5-3-9.1, the City's municipal water utility is hereby removed from the jurisdiction of the IURC for the approval of rates and charges and

the issuance of stocks, bonds, notes, or other evidence of indebtedness, and any other applicable matters.

- Section 2. Except as described in Section 3 hereof, this ordinance shall take effect sixty (60) days after the date of its adoption.
- Section 3. If, within sixty (60) days of the adoption of this Ordinance, the Council receives a petition: (i) that is signed by at least the number of the registered voters of the City required under Indiana Code § 3-8-6-3 to place a candidate on the ballot; and (ii) that requests the Council to submit the question of removal from the IURC jurisdiction to the registered voters of the City at the next election, the Council will certify the public question to the county election board in accordance with Indiana Code § 8-1.5-3-9.1.
- Section 4. Within thirty (30) days after this ordinance becomes effective, the Mayor and/or Clerk-Treasurer shall mail to the IURC written notice of the withdrawal of the City's municipal water utility from the IURC's jurisdiction.
